We are indeed at the start of a new period of European projects like Erasmus, in the financial span 2021-2027. But the New Call has not yet been published....

Erasmus is one of the most popular and **successful EU programmes**. Launched 34 years ago (°1987), it has helped around 10 million people to study, work or volunteer abroad.

Under Erasmus more than 2 000 transnational partnerships are established each year.

Twenty-one years after the Bologna Declaration (1999), the **European Higher Education Area** (EHEA) is today the largest educational area in the world.

EEA by 2025 → **European Education Area**

PREPARATIONS

On 17 December 2020 the EU adopted the next **Multiannual Financial Framework**(MFF) set to begin on 1 January, 2021.

The week before, the Council and the European Parliament had reached a political agreement on the regulation for Horizon Europe and on the Erasmus+ programme for 2021-2027.

- The German presidency of the Council and the European Parliament's negotiating team secured a provisional deal on the Erasmus+ programme for the **period** 2021-2027.
- The new programme will be much more **inclusive** than the current one and is expected to triple the number of participants, bringing them up to 12 million people.
- It will cover not only higher education, but all levels and types of education and training, which is reflected by the kept label "Erasmus+".
- It will be provided with a substantial budget of EUR 24.57 billion in current prices, which constitutes a significant increase compared to the amount for the current programme.

Erasmus+ 2021-2027



What we already heard:

- Erasmus+ 2021-2027 will be much more **inclusive** by offering access to learners in higher or general education, vocational education or training, adult education, non-formal learning, youth and active participation activities.
- It will also facilitate the participation of small scale and grassroots organisations, and **people with fewer opportunities**, including people with disabilities and migrants, as well as EU citizens living in remote areas.
- The inclusiveness of the programme is also strengthened by the provisions on **virtual learning and measures** such as language support, preparatory visits, training and virtual cooperation for people who are unable to participate in learning mobility in the field of education and training, youth and sport.
- Further to that, DiscoverEU, European Universities and Centres of vocational excellence initiatives are included in the scope of Erasmus+ 2021-2027.

Erasmus+ 2021-2027 (2)



The programme would maintain the same basic structure with three key actions.

- KA1: the first key action caters for **mobility**, also for school education, and VET also outside Europe, blended mobility, and
 - Blended Intensive programmes (3 HEIs from at least 3 programme countries + virtual component = 3 ECTS)
- KA2: the second focuses on **cooperation** for innovation and the exchange of **best practices**, centralized and decentralized
- KA3: while the third supports **policy development.**

In short.... and let's start dreaming....

The next Erasmus+ Programme intends to be

- more inclusive and accessible with simpler application processes as well as
- enhanced international mobility and cooperation.

The improved programme will invest in

- innovative fields of study such as
 - renewable energy,
 - environmentalism, environmental engineering, and
 - artificial intelligence



Keeping in mind that by providing more people with the opportunity to learn, gain experience and partake in cross border mobility the Erasmus+ programme

• will continue to strengthen Europe's economy and community while tackling global issues and promoting social equality.

In between.....Brexit

- The UK programme will be called TURING Scheme
- The EU will keep to ERASMUS+

- Horizontal priorities of the Call : inclusion/innovation/green/digital
- And some more... you can tick off!
- Also take into account possible priorities of the NA



And then say **WHY** you go for these priorities: and don't limit yourself to 5 words!!!

Relevance of the project (2)

You do all this based on a genuine and adequate **needs analysis**

- Therefore:
- Consult recent academic publications on the topic linked to your focus group
- Consult European studies on the topic



See what the European Commissioner for Innovation, Research, **Education** and Youth has been focusing on in her latest speeches **Mariya Gabriel** (BG)

• This will lead you to describe your **objectives**, please as clearly as possible and always linked to what is needed and what your priorities are.

Relevance of the project (3)

Make sure that you project is Innovative and/or complementary.

- No copy paste of another project!
- Possibility of checking on previous projects which were accepted and funded: Erasmus+ Project Results Platform. See:





Synergies between individuals, organisations, partnerships have to be emphasized. You or your institution are not alone with your project!

Relevance of the project (4)

Asking for European money means also stressing the added value of your project at EU level,

and so not only for your organisation, your local environment, your region, your country, but for all Europeans! and this way claiming global citizenship!

Project design and implementation

Description of the work programme with all the phases:

- Preparation
- Implementation
- Monitoring
- Evaluation
- Dissemination



All these phases have to be dissected in detail! Make sure to involve all the key-actors of the different organisations of your team.

Project Design - Activities

Start drawing a timeline and then develop the GANTT chart

- Transnational meetings
- Intellectual Outputs (results of studies)
- Teaching, Training, Learning Activities (important not to forget the validation of the formal or non-formal learning activities)
- Multiplier Events
- Ips (new Call?)

• Consistency?

• Feasable? Qualitative?

What quality control measures have you foreseen?

- High quality?
- Will it be completed in time?
- What about the budget? Too little, too much?

Will the results be **cost effective** and

The **resources foreseen** for each activity:

• realistic?

And then: which **online platforms** will you use:

eTwinning, EPALE, School Education Gateway, and not only your own website!

Quality of the project team and the cooperation arrangements



The Team?

- Involving an **appropriate mix** of complementary participating organisations
 - Profile, experience, expertise of the organisation but also
 - Of the key-actors per organisation
- Distribution of responsibilities and tasks: please in equilibrium! Not all activities in hands of the applicant!
- Active contribution of all organisations: why otherwise allocate them money?
- Effective mechanisms for coordination and communication: in detail!
 What if there are problems?

What if there are problems?



More on the team....

- If relevant: **organisations of different fields** of education, training, youth and socio-economic sectors
- Newcomers to the Action?

Is interesting to mention this!

Now some vocabulary first: **Programme/Partner**???



- Programme countries? The 27 EU countries and also North Macedonia, Iceland, Liechtenstein, Norway, Serbia, Turkey
- Partner countries? The rest of the World! But....subdivided in 14 Regions (linked to the financing by the EU of these Regions). *UK? Region 15*?

Note: in some Actions it is essential to give evidence why the partner brings in an **additional value** to the project.

Dissemination and Implementation

What measures will you use to **evaluate** the outcomes of the project? because you aim to have impact *"during and after"* on

- the participants
- the participating organisations
- but also at local, regional, national and European levels
 Which measurements will you use? Qualitative? Quantitative?

And how is your **dissemination plan**? What measures will you take for sharing the outcomes of the project

- within and
- outside the participating organisations

And don't limit yourself to

And then what to do with the materials, documents, media you produced?



No!

So NO patent! **You don't have** an exclusive right to make or sell a product or exploit an invention based on EU money!



The products (materials, documents, media...) of the project will be made **FREELY available** and promoted through open licences, without limitations...

- Important to mention **which partner will take care** of this after the lifetime of the project.
- **Platforms**: EPALE, Erasmus+ Project result Platform for implementaion and follow-up of the project
